- 5. That there is now due and owing the Claimant after allowing to the owner all credits, deductions and set-offs, One Hundred Thirty-Seven Thousand Five Hundred Seventy-Eight Dollars (\$137,578.00), which is still due and unpaid.
- 6. That the Claimant now claims a lien on the above-described Premises and all improvements on it, against all persons interested, for One Hundred Thirty-Seven Thousand Five Hundred Seventy-Eight Dollars (\$ 137,578.00), with interest, according to the statute.
