AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF DEER PARK

672 THROUGH 776 HILLCREST ROAD

WHEREAS, the owners of record and a majority of the electors residing on the territory legally described and depicted on the plat attached hereto as Exhibit A (the "Property") have petitioned the Village of Deer Park, Lake and Cook Counties (hereinafter the "Village") requesting that the Freperty be annexed to the Village;

WHEREAS, the Board of Trustees of the Village has considered the matter and made the following findings of fact:

- 1. The Property is in the county of Cook and State of Illinois.




