THIS SUBORDINATION AGREEMENT, made in the City of Chicago, State of Illinois this 11th day of March, 2003, by LaSalle Bank, NA, a national banking association organized and existing under and by virtue of the laws of the United States of America, and doing business and State of Illinois ("Bank"). Witnesseth WHEREAS, the Bank is the owner of a mortgage dated May 25, 2002 and recorded June 4, 2002 among the land records in the Office of the Recorder of Deeds of Cook County, Illinois as document number 0020621366 made by Robert Parris and Cynthia M. That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's reflecting and securing the loan mide by Mortgagee to Borrower, in the amount of Three mortgage dated Hundred One Thousand Dollars and no/100 and to all renewals, extensions of replace news of said Mortgagee's mortgage; and 2. That this Agreement shall be binding upon and shall insure to the benefit of Mortgagee, its successors and assigns.
