WHEREAS, the Corporate Authorities of the Village of Tinley Park after due consideration have determined that it is in the best interest of the Village and its residents that the attached Plat of Dedication be appropriately recorded.

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Tinley Park, Cool 202 Will Counties, Illinois, as follows:

Section 1: That the plat attached as <u>EXHIBIT A</u> to this Ordinance, delineating dedication, Tinley Park, Cook County, Illinois, and tided "Plat of Dedication" be and hereby is approved.

Section 2: That the legal description of the property shown on said plat is:
