TERMS AND CONDITIONS

This conveyance is made upon the express understanding and condition that neither *ColeTaylorBank*, individually or as Trustee, nor its successor or successors in trust shall incur any personal liability or be subjected to any claim, judgment or decree for anything it or they or its or their agents or attorneys may do
