All property subject to the Deed of Trust.

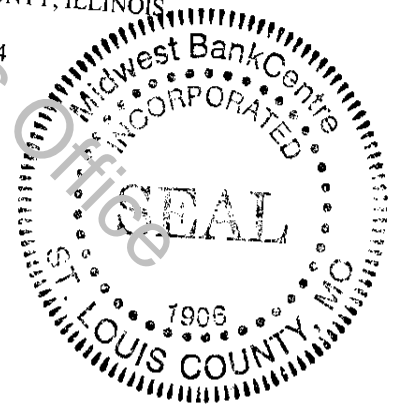
The following specific property is released from the Deed of Trust, all other property shall remain subject to the Deed of Trust:
