WITNESSETH, that Grantor, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration in hand paid, by the Grantee, the receipt and sufficiency whereof is hereby acknowledged, by these presents does GRANT AND CONVEY with special warranty covenants unto Grantee, and its successors and assigns, FOREVER, all of the following described real estate, situated in the County of Cook and State of Illinois:

Grantor also hereby grants to Grantee, its successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of the property set forth in that certain Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for the 420 W. Ontario Residential Condominium Association recorded October 6, 1999 in the Cook County Recorder's Office as Document No. 99947221 (the "Original Declaration"), as amended by that certain First Amendment to Condominium Declaration recorded December 13, 2001 as Document No. 0011182379 ("First Amendment"), as further amended by Second Amendment to Condominium Declaration recorded on October 8, 2002 as Document No. 0021164860 ("Second Amendment"), as further amended by Third Amendment to Condominium Declaration recorded April 30, 2003 as Document No. 0312019071 ("Third Amendment"), (the Original Declaration, First Amendment, Second Amendment and Third Amendment are collectively referred to herein as the "Declaration") and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in the Declaration for the benefit of the remaining property described therein.


