It is agreed that Lerdor incurs no liability for not taking any or all actions authorized under this Section 9.

Any amounts disbursed by Lender vaider this Section 9 shall become additional debt of Borrower secured by this Security Instrument. These amounts shall bear interest at the Note rate from the date of disbursement and shall be payable, with such interest, upon notice from Lender to Borrower requesting payment.
