quotations of 5 major banks (LIBCR), as published in the Wall Street Journal. If the Index is no longer
available the Note Holder will choose a new Index which is based upon comparable information. The
Note Holder will give me notice of this choice. The most recent Index figure available as of the date 45
days before each Change Date is called 40% "Current Index." Before each Change Date, the Note Holder
will calculate my new interest rate by adding 6.150 % to the Current Index. The Note Holder will
then determine the amount of the monthly pay nent that would be sufficient to repay the unpaid principal
that I am expected to owe at the Change Date in full on the Maturity Date at my new interest rate in
substantially equal payments. The result of this calculation will be the new amount of my monthly
newment. The interest rate I am required to pay at the first Change Date will not be greater than
10.650 % or less than 4.650 %. Thereafter, an interest rate will never be increased or
decreased on any single Change Date by more than 1.70 % from the rate of interest I have been
paying for the proceeding 6 months. My interest rate will never be greater than 13.650 %.
My new interest rate will become effective on each Change Date a vill pay the amount of my new
