THIS MATTER COMING to be heard on Motion of the Plaintiff and it appearing to the Court that:

1. A Final Judgment Order was entered on January 10, 2002, adjudging that the sum of Three Hundred and Ten Thousand Dollars and No Cents (\$310,000.00) for Parcel OCR0034 was the full compensation to be paid to the owner or owners of and all parties otherwise interested in the real property, for the fee simple title to the real estate legally described in Exhibit A.

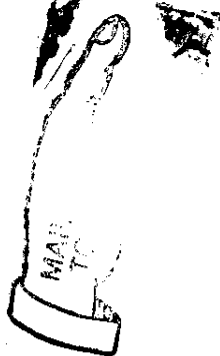

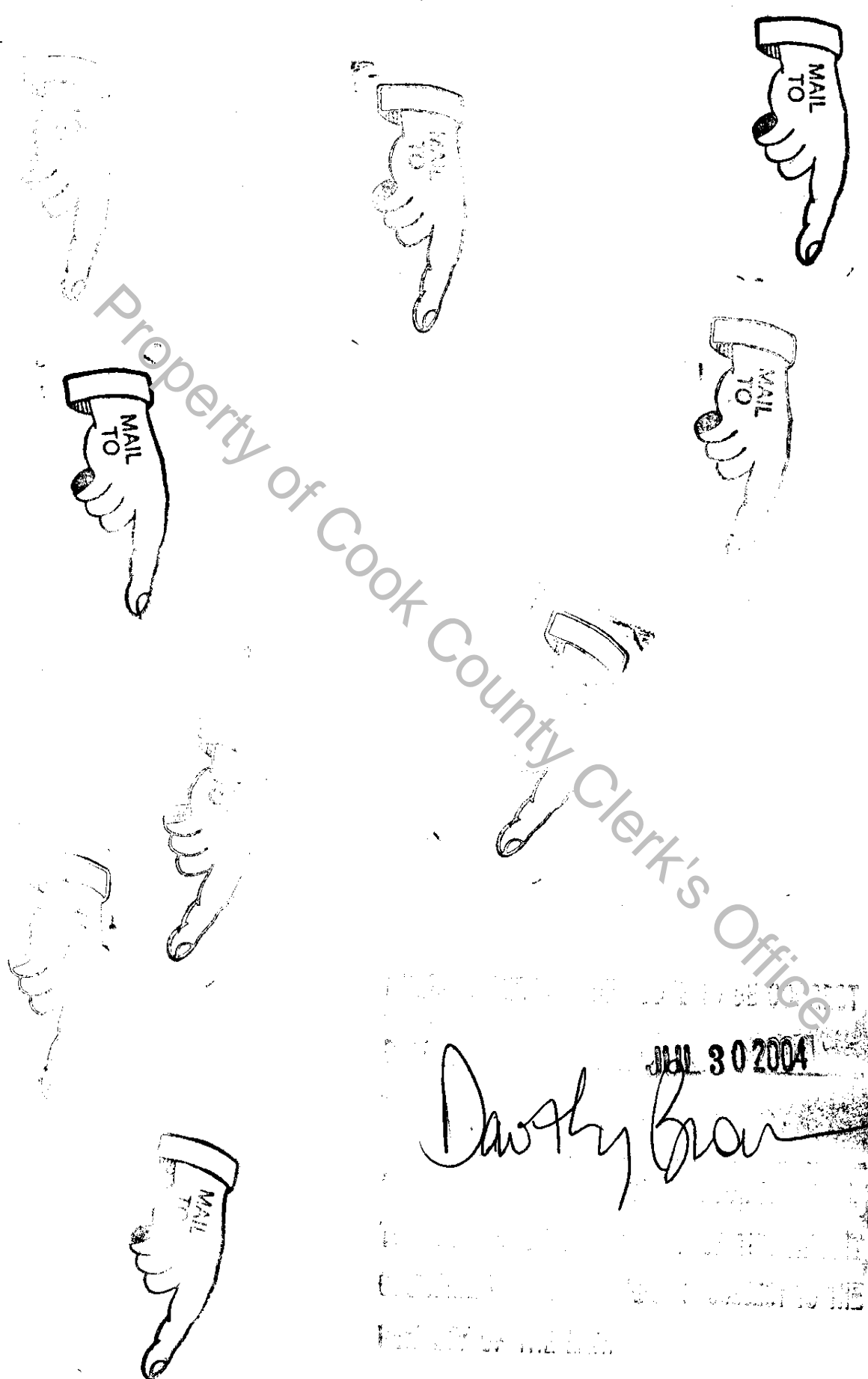
