FIRST AMENDMENT TO MORTGAGE AND SECURITY AGREEMENT

THIS FIRST AMENDMENT TO MORTGAGE AND SECURITY AGREEMENT (the "First Amendment") is made and entered into as of the diay of July, 2004, by and between

DIVERSEY II, L.L.C., an Illinois limited liability company (the "Mortgagor"); and

WACHOVIA BANK, NATIONAL ASSOCIATION, a national banking association (the "Mortgagee").

RECITALS:

WHEIEAS, Mortgagor executed a Mortgage and Security Agreement (the "Mortgage") for the benefit of Mortgagee dated as of May 20, 2004, and recorded as Instrument No. 0414220108 with the Cook County Recorder of Deeds, covering the Mortgaged Property;

WHEREAS, Mortgagor and Mortgagee wish to amend the Mortgage in order to cross-collateralize and cross-default certain other mortgage loans with the loan evidenced by the Note and secured by the Mortgagor, al' as more particularly set forth herein; and

WHEREAS, capitalized term used herein and not otherwise defined shall have the respective meanings set forth in the Morigage.

NOW, THEREFORE, the Mortgagor an 1 the Mortgagee hereby agree as follows:

- 1. Section 4.35 of the Mortgage is hereby am ended as follows:
- (a) The words "the Lender" in subparagraphs (a), (b), (c) and (d) are deleted and replaced with the word "Mortgagee".
 - (b) The word "and" is deleted at the end of subpart graph (c).
- (c) The period is deleted at the end of subparagraph (d) as d replaced with a semicolon.
- (d) The following new subparagraphs (e), (f), (g), (h) and (r) are added immediately following subparagraph (d):
 - "(e) Loan in the original principal amount of \$14,198,000.00 evidenced by a Promissory Note executed by Wrightwood II, L.L.C. and payable to the Mortgagee dated of even date herewith, in such principal amount, secured by property located in Cook County, Illinois ("Wrightwood II Loan");
 - (f) Loan in the original principal amount of \$14,240,000.00 evidenced by a Promissory Note executed by Elm II, L.L.C. and payable to the Mortgagee dated of even date herewith, in such principal amount, secured by property located in Cook County, Illinois ("Elm II Loan");

- (g) Loan in the original principal amount of \$20,207,000.00 evidenced by a Promissory Note executed by Delaware II, L.L.C. and payable to the Mortgagee dated of even date herewith, in such principal amount, secured by property located in Cook County, Illinois ("Delaware II Loan");
- (h) Loan in the original principal amount of \$30,051,000.00 evidenced by a Promissory Note executed by 4100 Marine, L.L.C. and payable to the Mortgagee dated of even date herewith, in such principal amount, secured by property located in Cook County, Illinois ("4100 Marine Loan"); and
- (i) Loan in the original principal amount of \$17,520,000.00 evidenced by a Promissory Note executed by Wrightwood III, L.L.C. and payable to the Mortgagee dated of even date herewith, in such principal amount, secured by property located in Cook County, Illinois ("Wrightwood III Loan")."
- 2. Section 2.1(n) is hereby amended as follows:
- (a) The word 'or" immediately following the words "the Deming I Loan" is deleted and replaced with ϵ co nma.
- (b) Immediately following the words "the Wrightwood IV Loan," the following words are inserted: "the Wrightwood II Loan, the Wrightwood III Loan, the Elm II Loan, the Delaware II Loan or the 4100 Marine Loan,"
- 3. As expressly modified hereby, the terms and conditions of the Mortgage remain in full force and effect.
- 4. This First Amendment shall be deemed to be a contract made under, and for all purposes shall be construed in accordance with, the laws of the State of Illinois.
- 5. This First Amendment may be executed in any number of counterparts, each of which shall be effective only upon delivery and thereafter shall be deened an original, and all of which shall be taken to be one and the same instrument, for the same effect as it all parties hereto had signed the same signature page. Any signature page of this First Amendment may be detached from any counterpart of this First Amendment without impairing the legal effect of any signatures thereon and may be attached to another counterpart of this First Amendment identical in form hereto but having attached to it one or more additional signature pages.
