### JUNIOR MORTGAGE, SECURITY AGREEMENT AND FINANCING STATEMENT

THIS JUNIOR MORTGAGE, SECURITY AGREEMENT AND FINANCING STATEMENT ("Mortgage") is made as of this 1st day of August, 2004, by Jazz on the Boulevard, LLC, a Delaware limited liability company ("Mortgagor"), to the City of Chicago,

Illinois together with its successors and assigns, having its principal office at 121 North LaSalle Street, Chicago, Illinois 60602 ("Mortgagee").

All capitalized terms, unless defined herein, shall have the same meanings as are set forth in that certain Housing Loan Agreement dated of even date herewith between Mortgagor, Drexel Jazz Limited Partnership, an Illinois limited partnership ("Permanent Borrower") and Mortgagee (herein as the same may be amended, supplemented or restated from time to time called the "Loan Agreement").

#### WITNESSETH:

WHEREAS, Mortgagor has concurrently herewith executed and delivered a promissory note bearing even date herewith, in the principal sum as described on Exhibit B attached hereto and hereby made a point hereof, and made payable to Mortgagee (herein such note together with all amendments or supplements thereto, extensions thereof and notes which may be taken in whole or partial renewal, substitution or extension thereof shall be called the "Note") in which Mortgagor promises to pay said principal sum, plus interest, if any, thereon at the rate specified on Exhibit B hereto, and the ma urity of which note is described on Exhibit B hereto; and

WHEREAS, Mortgagee desires to secure repayment of the indebtedness evidenced by the Note, together with interest, if any, there on, in accordance with the terms of the Loan Documents and any additional indebtedness or obligations incurred by Mortgagor on account of any future payments, advances or expenditures made by Mortgagee pursuant to the Loan Documents; and

WHEREAS, the Loan Documents contemplate the construction of a mixed-income development having, in aggregate, 63 buildings and 137 residential units and certain associated infrastructure improvements, parking facilities, open space and common areas; and

WHEREAS, 39 units of the residential units shall be Project Units conveyed to the Permanent Borrower and thereafter operated by the Permanent Borrower as residential rental property, and 98 of the residential units shall be "for sale" units sold to private purchasers (such entire 137 unit mixed-income development, the "Mixed-Income Project," and the residential rental component including the Project Units, the "Project"); and

WHEREAS, the City shall initially disburse the Loan proceeds to the Mortgagor for its construction of Project Units; and

WHEREAS, upon the Mortgagor's construction of a Project Unit, the conversion of the subject property to a condominium form of ownership (if such Project Unit is in a multi-family building) and the recording of a deed conveying such Unit from the Mortgagor to the Permanent Borrower, the Permanent Borrower shall execute, deliver and record the Replacement Loan Documents, including the New City Mortgage (as defined in Section 40) and assume a portion of

the Loan equal to the allocated amount for such Project Unit as listed on <u>Schedule 1</u> to the Loan Agreement, and shall, subject to the Mortgagor's continuing obligations under Section 23 and Section 33 of the Loan Agreement, assume the other obligations applicable to such Project Unit under the Replacement Loan Documents; and

WHEREAS, as additional Project Units are conveyed from time to time, the Replacement Loan Documents shall be amended to reflect such conveyance and the Permanent Borrower's further assumption of allocable portions of the Loan and other obligations applicable to such Project Units; and

WEEREAS, as of the date hereof, the Premises are legally described on Exhibit A attached hereto and consists of the subdivided lots and other legally described parcels of real property described therein; and

WHEREAS, '.pon the Mortgagor's submission of the subdivided lots on which the Project Units will be built to the Illinois Condominium Property Act and a condominium form of ownership, it will be possible to separately describe and encumber the 35 Project Units that cannot presently be separately described and encumbered, which shall be accomplished by the Permanent Borrower's execution, delivery and recording of the New City Mortgage and the other Replacement Loan Documents (which shall also describe and encumber the 4 Project Units that are single-family townhomes); and

WHEREAS, upon construction of a Project Unit, the conversion of the subject property to a condominium form of ownership (if such Project Unit is located in a multi-family building), and the recording of a deed conveying such Project Unit to the Permanent Borrower, the Mortgagee will release the lien granted hereunder in exchange for a lien on the now separately described and encumbered Project Unit, as described in more detail in Sections 40 and 41 hereof; and

WHEREAS, the CHA Senior Lender will also provide financial assistance for the Project provided by the U.S. Department of Housing and Urban Development ("HUD") under the U.S. Housing Act of 1937 (42 U.S.C. 1437, et seq.) (the "1937 Act") with respect to the 30 public housing units included in the Project (the "Project PHUs") and, in exchange for such assistance, the Mortgagor will agree to develop, and the Permanent Borrower will agree to operate and maintain, such Project PHUs in accordance with all requirements applicable to public housing, including the 1937 Act, HUD regulations thereunder (and, to the extent applicable, any HUD-approved waivers of regulatory requirements), the Annual Contributions Contract executed between the CHA Senior Lender and HUD ("ACC"), the Mixed Finance Amendment adding the Project Units to the ACC, the CHA Senior Declaration and all pertinent Federal statutory, executive order and regulatory requirements, as those requirements may be amended from time to time (all such requirements hereafter collectively referred to as the "Applicable Public Housing Requirements");

NOW, THEREFORE, in order to secure payment of principal and interest, if any, under the Note and of all other payments due to Mortgagee by Mortgagor under any of the Loan Documents and performance of the covenants and agreements contained in this Mortgage, including any substitutions, extensions or modifications hereto, Mortgagor does grant, assign, warrant, convey and mortgage to Mortgagee, its successors and assigns, and grants to Mortgagee, its successors and assigns forever a continuing security interest in and to, all of the following rights, interests, claims and property:

- (A) all of the Mortgagor's interest and rights (i) as tenant under each of those certain Ground Lease Agreements described on Exhibit A, as the same may be amended, modified, and supplemented from time to time in accordance with their terms (the "Ground Lease"), demising the real estate more particularly described as on Exhibit A as the "North Parcel Leased Property (Leasehold Estate)" and (ii) as fee simple owner of the real estate more particularly described on Exhibit A as the "Valdle Parcel (Fee Simple)" and "South Parcel (Fee Simple)" together with all of the Mortgagor's interest in infrastructure improvements, parking facilities, open spaces and common areas, easements (including, without limitation, the easements granted under that certain Declaration of Covenants, Conditions, Restrictions and Easements dated August 1, 2004 and recorded in the Recorder's Offic and Cook County), water rights, hereditaments, mineral rights and other rights and interests appurtenant thereto (the "Real Property");
- (B) all buildings, structures and other improvements of every kind and description now or hereafter erected, situated or placed upon the Real Property, together with any fixtures or attachments now or hereafter owned by Mortgage; and located in or on, forming part of, attached to, used or intended to be used in connection with or incorporated in the Real Property, including all extensions, additions, betterments, renewals, substitutions and replacements of any of the foregoing (the "Improvements");
- (C) any interests, estates or other claims of every name, kind or nature, both at law and in equity, which Mortgagor now has or may acquire in the Real Troperty, the Improvements, the Equipment (as hereinafter defined) or any of the property described in clauses (D), (F), (G), (H) or (I) hereof;
- (D) all of Mortgagor's interest and rights as lessor in and to all leases, sucleases and agreements, written or oral, now or hereafter entered into, affecting the Real Proper v, the Improvements, the Equipment or any part thereof, and all income, rents, issues, proceeds and profits accruing therefrom (provided that the assignment hereby made shall not diminish or impair the obligations of Mortgagor under the provisions of such leases, subleases or agreements, nor shall such obligations be imposed on Mortgagee);
- (E) all right, title and interest of Mortgagor in and to all fixtures, personal property of any kind or character now or hereafter attached to, contained in and used or useful in connection with the Real Property or the Improvements, together with all furniture, furnishings, apparatus, goods, systems, fixtures and other items of personal property of every kind and nature, now or

hereafter located in, upon or affixed to the Real Property or the Improvements, or used or useful in connection with any present or future operation of the Real Property or the Improvements, including, but not limited to, all apparatus and equipment used to supply heat, gas, air conditioning, water, light, power, refrigeration, electricity, plumbing and ventilation, including all renewals, additions and accessories to and replacements of and substitutions for each and all of the foregoing, and all proceeds therefrom (the "Equipment");

- (F) all of the estate, interest, right, title or other claim or demand which Mortgagor now has or may acquire with respect to (i) proceeds of insurance in effect with respect to the Real Property, the Improvements or the Equipment, and (ii) any and all awards, claims for damages, judgments, settlements and other compensation made for or consequent upon the taking by condemnation, eminent domain or any like proceeding of all or any portion of the Real Property, the Improvements or the Equipment;
- (G) all intangible personal property, accounts, licenses, permits, instruments, contract rights, and chattel paper of Mortgagor, including, but not limited to cash, accounts receivable, bank accounts, certificates of deposit, rights (if any) to amounts held in escrow, deposits, judgments, liens and causes of action, warranties and guarantees, relating to the Real Property, the Equipment or the Improvements or as otherwise required under the Loan Documents;
- (H) all other property rights of Mortgagor of any kind or character related to all or any portion of the Real Property, the Improvements or the Equipment; and
- (I) the proceeds from the sale, transfer, pleage or other disposition of any or all of the property described in the preceding clauses.

All of the property referred to in the preceding clauses (A) through (I) shall be called, collectively, the "Premises."

IT IS FURTHER agreed, intended and declared that all the aforesaid property rights and interests shall, so far as permitted by law and as permitted by Applicable Public Housing Requirements, be deemed to form a part and parcel of the Premises and be covered by this Mortgage.

TO HAVE AND TO HOLD the Premises unto Mortgagee and its successors and assigns, forever, for the purposes and uses herein set forth.

If Mortgagor hereunder is described as a trustee under a trust agreement, said trust arrangement constitutes a "land trust" as said term is defined in Section 5/15-1205 of the Illinois Mortgage Foreclosure Law, 735 ILCS 5/15-1101 et seq., as amended, supplemented and restated from time to time (the "Act").

To protect the security of this Mortgage, Mortgagor further covenants and agrees as follows:

(1) <u>Principal and Interest</u>. Mortgagor shall pay promptly when due the principal of and interest, if any, on the Note and any other sums required to be paid on the Note or under the other Loan Documents at the times and in the manner provided therein and shall pay any other indebtedness secured hereby as the same becomes due and shall perform and observe all of the covenants, agreements and provisions contained herein and in the other Loan Documents.

Mortgagor shall pay promptly when due any sums due, and promptly and fully perform any acts required under the Senior Construction Loan Documents, the CHA Senior Loan Documents, the IHDA Senior Loan Documents (such other lenders, collectively, the "Other Senior Lenders' and such Other Senior Lenders' loan documents, collectively, the "Other Senior Lenders' Loan Documents") and the Ground Leases. Mortgagor will not, without prior written consent of Mortgagee, modify, extend or amend the Other Senior Lenders' Loan Documents or the Ground Leases to increase the amount of the indebtedness secured thereby or change the repayment terms of such indeptedness, if any, so as to increase or accelerate the repayment of such indebtedness, or so as to increase or accelerate the payment any rent, as applicable. Mortgagor shall promptly give Mortgagor to any other Lender, if any, pursuant to any of the Other Senior Lenders' Loan Documents.

- (2) <u>Preservation, Restoration and Use of Premises</u>. Mortgagor shall:
- (a) promptly repair, restore, replace or rebuild any portion of the Premises which may become damaged, destroyed, altered, removed, severed or demolished, whether or not insurance proceeds are available or sufficient for the purpose, with replacements at least equal in quality and condition as existed prior thereto, free from any security interest in, encumbrances on or reservation of title thereto except Permitted Encumbrances (including but not limited to those listed on Exhibit C hereto);
- (b) keep and maintain the Premises in good condition and repair, without waste, and free from mechanics' liens, materialmen's liens or other liens and claims except Permitted Encumbrances;
- (c) complete, within a reasonable time, any construction of improvements now or hereafter constructed upon the Premises;
- (d) comply with all statutes, rules, regulations, orders, decrees and other requirements of any federal, state or local governmental body having jurisdiction over the Premises and the use thereof, including all Applicable Public Housing Requirements, and observe and comply with any conditions and requirements necessary to preserve and extend any and all rights, licenses, permits (including without limitation zoning variances, special exceptions and non-conforming

uses), privileges, franchises and concessions that are applicable to the ownership, renovation, use and occupancy of the Premises;

- (e) upon completion of the Project, make no material alterations in the Premises (except those required by law) without Mortgagee's prior written consent;
- (f) upon completion of the Project, suffer or permit no change in the general nature of the occupancy or use of the Premises without Mortgagee's prior written consent, except as contemplated by Section 2(m) below and Section 40;
- (g) pay all operating costs of the Premises when due, including all utility charges and all other assessments or charges of a similar nature;
- (h) not initiate or acquiesce in any zoning reclassification with respect to the Premises, without Mongagee's prior written consent;
- (i) not abandon in Premises, nor do anything whatsoever to depreciate or impair the value of the Premises or the security of this Mortgage;
- (j) refrain from any action and correct any condition which would increase the risk of fire or other hazard to all or any portion of the Premises;
  - (k) not permit any unlawful use or naisance to exist upon the Premises;
- (l) comply with all instruments and documents of record or otherwise affecting the use or occupancy of all or any portion of the Premises; and
- (m) upon completion of any building containing a Project Unit, promptly submit such building to the Illinois Condominium Property Act (if such building is a multifamily building) and convey the Project Unit(s) in such building to the Permanent Borrower in accordance with the Real Estate Purchase and Sale Contract dated as of August 1, 2004 by and between the Mortgagor and the Permanent Borrower (the "Purchase and Sale Agreement"), free and clear of the lien of the Senior Construction Lender under the Senior Construction Loan Documents, any and all mechanic's liens and subject only to permitted exceptions acceptable to the Mortgagee.
- (3) Taxes and Charges. Mortgagor agrees to pay or cause to be paid, prior to delinquency, all Charges (as hereinafter defined) which are assessed or imposed upon the Premises or upon any of the Loan Documents, the Other Senior Lenders' Loan Documents, or become due and payable, and which create, may create or appear to create a lien upon the Premises or any part thereof or upon any of the Loan Documents, the Other Senior Lenders' Loan Documents; provided, however, that if by law any such Charge is payable or, at the option of Mortgagor, may be paid in installments, Mortgagor may pay the same together with any accrued interest on the unpaid balance of such Charge in installments as the same become due and before

any fine, penalty, interest or cost may be added thereto for the nonpayment of any such installment and interest. ("Charge" shall mean and include all federal, state, county, city, municipal or other governmental entity (or any instrumentality, division, agency, body or department thereof) taxes, levies, assessments, charges, liens, claims or encumbrances related to the Premises, Borrower's Liabilities, Mortgagor and/or Managing Member, or any of the Loan Documents, or the Other Senior Lenders' Loan Documents). Such payment covenant shall continue to be applicable with respect to portions of the Premises converted to a condominium form of ownership and conveyed to the Permanent Borrower or a private purchaser, and, as a result, no longer included in the Premises, with respect to charges attributable to the time period prior to such conversion and conveyance. The preceding sentence shall not apply, however, if and to the extent that, in connection with such conveyance, the Permanent Borrower or private purchaser received a credit at closing for an amount reasonably estimated to approximate such accrued but impending tax liability in consideration of such party's agreement to assume liability for payment of such taxes.

Mortgagor shall furnish Mortgagee within 30 days after the date upon which any Charge is due and payable by Mongagor, official receipts of the appropriate authority, or other proof satisfactory to Mortgagee, evidencing the payment thereof. Mortgagor shall have the right before any delinquency occurs to contest or object to the amount or validity of any Charge or mechanic's lien by appropriate legal proceedings properly instituted and prosecuted in such manner as shall stay collection of the contested Charge and prevent the imposition of a lien or (in the case of mechanic's liens or other Charges subject to forfeiture or foreclosure) the sale or forfeiture of the Premises to collect the same; provided that no such contest or objection shall be deemed or construed in any way as relieving, modifying or extending Mortgagor's covenant to pay any such Charge at the time and in the manner provided in this Mortgage unless Mortgagor has given prior written notice to Mortgagee of Mortgagor's intent to contest or object to a Charge and (i) Mortgagor shall demonstrate to Mortgagee's satisfaction that legal proceedings instituted by Mortgagor contesting or objecting to such Charge shall conclusively operate to prevent a lien against or the sale or forfeiture of the Premises or any part thereof (ir cluding portions previously converted to a condominium form of ownership and conveyed to Permanent Borrower or a private purchaser, if such charge relates to the time period prior to such conversion and conveyance) as satisfaction of such Charge prior to final determination of such proceedings, and (ii) Mortgagor shall furnish to Mortgagee or Senior Lender, if any, (and if to Senior Lender, notice thereof to Mortgagee) a good and sufficient bond or surety, or a good and sufficient undertaking as may be required or permitted by law to accomplish a stay of any such sale or forfeiture of the Premises during the pendency of such contest, in an amount (x) not less than 125% of such Charge and (y) adequate fully to pay all such contested Charges and all interest and penalties upon the adverse determination of such contest.

(4) <u>Insurance</u>. Mortgagor shall procure and maintain, or cause the General Contractor or other responsible party to maintain, at all times, at Mortgagor's own expense, until final repayment of the indebtedness secured hereby, the types of insurance specified below, with insurance companies authorized to do business in the State of Illinois covering all operations

contemplated in connection with the Project, whether performed by Mortgagor, the General Contractor, any Subcontractor or others.

The kinds and amounts of insurance required are as follows:

### (a) Workers Compensation and Occupational Disease Insurance

Workers compensation and occupational disease insurance, in accordance with the laws of the State of Illinois, or any other applicable jurisdiction, covering all employees who are to provide a service in connection with the Project and employer's liability coverage with limits of not less than \$100,000 per each accident or illness.

### (b) <u>Commercial Liability Insurance</u> (Primary and Umbrella)

Commercial liability insurance or equivalent with limits of not less than \$1,000,000 per occurrence, combined single limit, for bodily injury, personal injury and/or property damage liability. Coverage extensions shall include the following: all premises and operations, products/completed operation, independent contractors cross liability and contractual liability coverages (with no limitation endorsement). Mortgagee, its employees, elected officials, agents and representatives and other applicable lenders shall be named as an additional insured on a primary, non-contributory basis for any liability arising directly or indirectly from the Project.

### (c) <u>Automobile Liability Insurance</u> (Primary and Umbrella)

When any motor vehicles (owned, non-owned and pired) are used in connection with the Project, Mortgagor shall provide comprehens we automobile liability insurance with limits of not less than \$1,000,000 per occurrence, combined single limit, for bodily injury and property damage. Mortgagee shall be named as an additional insured on a primary, non-contributory basis.

### (d) All Risk Property Damage

Mortgagor shall obtain an all risk property policy in the amount of full replacement value, including improvements and betterments, covering damage to or loss of the Premises. The insurance shall include the following extensions: business interruption/loss of rents, and boiler and machinery, if applicable. The policy shall list Mortgagee as loss payee as their interest may appear.

### (e) All Risk Builders Risk Insurance

When Mortgagor, the General Contractor or any Subcontractor undertakes any construction, including improvements, betterments and/or repairs, to the Premises, all risk builder's risk insurance shall be procured and maintained to cover materials, supplies, equipment, machinery and fixtures that are or will be part of the Premises. Mortgagee shall be named as loss payee as their interest may appear.

#### (f) Railroad Protective Liability Insurance

When, in connection with the Project, any work is to be done adjacent to or on property owned by a railroad or public transit entity, Mortgagor shall procure and maintain, or cause to be procured and maintained, with respect to the operations that Mortgagor, the General Contractor or any Subcontractor shall perform, railroad protective liability insurance in the name of such railroad or public transit entity. The policy shall have limits of not less than \$2,000,000 per occurrence, combined single limit, and \$6,000,000 in the aggregate for losses arising out of injuries to or death of all persons, and for damage to or destruction of property, including the loss of use thereof.

### (g) Contractors' Pollution Lightity Insurance

When any environmental remediation work is undertaken by Mortgagor, the General Contractor or any Subcontractor in connection with the Project, contractors' pollution liability insurance shall be procured with limits of not less than \$1,000,000 covering all construction and related work undertaken in connection with the Project. Mortgagee is to be named as an additional insured on a primary, non-contributory basis. Mortgagor, the General Contractor and any Subcontractor shall comply with any additional insurance requirements that are stipulated by the Interstate Commerce Commission's regulations, Title 49 of the Code of Federal Regulations, Department of Transportation; Title 40 of the Code of Federal Regulations, Protection of the Environment and my other federal, state or local regulations concerning the removal and transportation of Pazardous Materials.

Mortgagor shall furnish the City of Chicago, Department of Housing, 318 South Michigan Avenue, Chicago, Illinois 60604, original certificates of insurance evidencing the required coverages to be in force on the date hereof, and renewal certificates of insurance, or such similar evidence, if the coverages have an expiration or renewal date occurring during the term hereof.

The receipt of any certificate does not constitute agreement by Mortgagee that the insurance requirements of this Section have been fully met or that the insurance policies indicated on the certificate are in compliance with all requirements. The failure of Mortgagee to obtain certificates or other insurance evidence from Mortgagor shall not be deemed to be a

waiver by Mortgagee. Mortgagor shall advise all insurers of the provisions of this Section regarding insurance. Non-conforming insurance shall not relieve Mortgagor of its obligation to provide insurance as specified herein. Nonfulfillment of the insurance conditions of this Section may constitute an Event of Default, and Mortgagee retains the right to suspend disbursement of Loan proceeds until proper evidence of insurance is provided.

All insurance policies shall provide that Mortgagee shall be given 30 days' prior written notice of any modification, nonrenewal or cancellation.

If Mortgagor fails to obtain or maintain any of the insurance policies required under this Mortgago or to pay any premium in whole or in part when due, Mortgagee may (without waiving or releasing any obligation or Event of Default by Mortgagor hereunder) obtain and maintain such insurance policies and take any other action which Mortgagee deems advisable to protect its interest in the Premices, including acceleration of the Note. All sums so disbursed by Mortgagee, including attorneys' tens, court costs and expenses, shall be reimbursed by Mortgagor upon demand by Mortgagee.

Mortgagor shall require the General Contractor and all Subcontractors to carry the insurance required herein, or Mortgagor may provide the coverage for any or all of the General Contractor and Subcontractors, and, if so, the evidence of insurance submitted shall so stipulate.

Any and all deductibles or self-insured retention on the insurance coverages required herein shall be borne by Mortgagor, the General Contractor or the appropriate Subcontractor, as applicable.

Mortgagor expressly understands and agrees that any insurance coverages and limits furnished by Mortgagor shall in no way limit Mortgagor's liabilities and responsibilities specified under any of the Loan Documents or by law.

The insurance required hereunder to be carried shall not be limited by any limitations expressed in the indemnification language herein or any limitation placed on the indemnity therein given as a matter of law.

If Mortgagor, the General Contractor or any Subcontractor desires additional coverage, higher limits of liability, or other modifications for its own protection, Mortgagor, the General Contractor or such Subcontractor, as appropriate, shall be responsible for the acquisition and cost of such additional protection.


