Assignor now desires to transfer all of its rights under the Mortgage to Assignee.





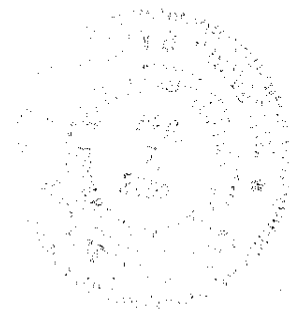
