JUDGMENT ORDER

This cause coming on to be heard on the Amended Petition for Setting Final Fees and Costs filed by The Muller Firm, Ltd., former counsel of record for Petitioner Grace Navarro, and for preliminary hearing, due notice having been given, the Court finding that it has jurisdiction of the parties and of the subject matter, and the Court being otherwise fully advised in the premises, THE COURT HEREBY MAKES FINDINGS AS FOLLOWS:

- 1. Former Counsel of Record The Muller Firm, Ltd. has fully complied with 750 ILCS 5/508(c)(3) and Cook County General Order 03 D 8 ("Cook County Implementation of Alternative Dispute Resolution Provisions of 750 ILCS 5/508(c)(4)") in that its Amended Fee Petition contains the requisite documents of: affidavit of attorney, copies of signed retainer agreement for legal services, statement of client's rights and responsibilities, detailed itemized statements of professional legal services rendered and costs, and notice of alternative dispute resolution ("ADR") procedure.
 - 2. That Petitioner Grace Navarro's failure to affirmatively opt either for or against ADR

constitutes a waiver of alternative dispute resolution/mediation.

- 3. That Petitioner Grace Navarro is defaulted for failure to file written response to said Fee Petition after having been granted additional time within which to do so.
- 4. That The Muller Firm, Ltd. has waived contribution from Respondent Gustavo Navarro.

IT IS HEREBY ORDERED:

- 1. The Muller Firm, Ltd.'s Amended Petition for Setting Final Fees and Costs against Petitioner Crace Navarro is granted.
- 2. That judgment is entered in favor of The Muller Firm, Ltd. and against Grace Navarro in the amount of THOUSAND ONE. HUNDRED THREE DOLLARS AND 100 (\$_1,103.46_).
- 3.
