EXHIBIT A

DESCRIPTION OF COLLATERAL

- (a) All apparatus, machinery, devices, fixtures, communication devices, systems and equipment, fittings, appurtenances, equipment, appliances, furniture, furnishings, appointments, accessories, landscaping, plants and all other items of personal property located at the property identified herein in Exhibit B (the "Property") or used in the operation or maintenance of the Property.
