Payments on the Note are to be made in accordance with the following payment schedule: in one principal rayment of \$50,000.00 plus interest on August 9, 2005. This payment due on August 9, 2005, will be for all principal and all accrued interest not yet paid. In addition, Grantor will pay regular monthly payments of all accrued unnaid interest due as of each payment date, beginning September 9, 2004, with all subsequent interest payments of the index, and therefore the total amount secured hereunder, will increase.
