APPLICATION OF BORROWER'S PAYMENTS 3.

Unless the law requires otherwise, Lender will apply each of my payments under the Secured Notes and under Paragraphs 1 and 2 above in the following order and for the following purposes:

First, to pay prepayment charges due under the Secured Notes;

These rights to bring legal action may include an action for breach of contract, fraud, concealment of a material fact or for intentional or negligent acts.
