THIS CONDOMINIUM RIDER is made this 25th day of August , 2004 , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Note to TCF National Bank,

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as: KATHLEEN DR CONDOMINIUM

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.

In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

- Condominium Obligations. Borrower shall perform all of Borrower's obligations under the Condominium Project's Constituent Documents.
