This matter coming before the Court on Plaintiff's Verified Complaint for entry of judgment on Industrial Commission Award, due notice having been given,

IT IS HEREBY ORDERED:

1. Judgment is entered in favor of Plaintiff Gary K. Goebel and against Defendants, Leo Pusateri, Kos Pusateri and Suzanne Pusateri, individually and d/b/a Leo Pusateri & Sons in the amount of \$6,220.59, calculated as follows:

\$29,192.94 (\$160.54 per week for September 18, 2000 - March 17, 2004)
+ 3,809.75 (penalties)
+ 1,523.90 (attorneys' fees)

\$34,526.59 (total due before credit paid by Defendants)
- 28,306.00 (credit paid by Defendants)
\$ 6,220.59 (total due as of March 17, 2004)

2. This Court to retain jurisdiction over Defendants' ongoing obligation to pay Plaintiff \$160.54 per week for his lifetime.


