AN ORDINANCE VACATING AN ALLEY IN THE VILLAGE OF SUMMIT, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SUMMIT COOK COUNTY, ILDNOIS, AS FOLLOWS:

SECTION 1: Pursuant to Section 11-91-1 of the Illinois Municipal ILCS 5/11-91-1, the

Village of Summit hereby vacates that certain alley legally described as follows:

NOOD THE

THE SOUTH 228.24 FEET OF AN ALLEY LOCATED IN LOT 22 OF FREDERICK H. BARTTLETT'S ARGO PARK SUBDIVISION OF THE EAST HALF OF THE SOUTHEAST QUARTER (EXCEPT RATLROAD) IN SECTION 13, TOWNSHIP 38 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF LOT 22 THENCE NORTH 89 DEGREES 47 MINUTES 27 SECONDS WEST ALONG THE NORTH RIGHT OF WAY LINE OF 60TH STREET TO THE POINT OF BEGINNING, SAID POINT BEING A DRILL HOLE WITH A P.K. NAIL, THENCE CONTINUING NORTH 89 DEGREES 47 MINUTES 27 SECONDS WEST ALONG SAID NORTH RIGHT OF WAY LINE, A DISTANCE OF 16.00 FEET; THENCE NORTH 00 DEGREES 00 MINUTES 02 SECONDS EAST, A DISTANCE OF 228.24 FEET TO A

POINT; THENCE SOUTH 89 DEGREES 37 MINUTES 50 SECONDS EAST, A DISTANCE OF 16.00 FEET TO A POINT; THENCE SOUTH 00 DEGREES 00 MINUTES 02 SECONDS WEST A DISTANCE OF 228.24 FEET TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS 0.08 ACRES. OR 3,652 SQUARE FEET MORE OR LESS.

The alley is depicted on a Flat of Vacation attached hereto as Exhibit A.

SECTION 2: The Village of Summit hereby reserves an easement in the vacated portion of the alley to allow its continued use by fire, police and other emergency vehicles, services and personnel.

SECTION 3: As required by Section 11-91-1 of the Illinois Municipal Code, the corporate authorities of the Village of Summi. hereby determine that the public interest will be subserved by the vacation of this alley.

SECTION 4: Title to the vacated portion of the alley shall devolve upon the owners of property east and adjacent to the vacated alley, having tax identification numbers 18-13-408-004 and 18-13-408-005. The Village hereby finds that compensation from such property owner to the Village is inappropriate, and therefore expressly waives any right to compensation.

SECTION 5: The Clerk shall cause a true and correct copy of this Ordinance and the Plat of Vacation to be filed with the Recorder of Deeds of Cook County, Illinois.

SECTION 6: This Ordinance is effective immediately.
