EXHIBIT "A"

LEGAL DESCRIPTION

Unit No. 1708 as delineated on survey of that part of Lot A described as follows:

Commencing at a Point on the East line of said Lot, 90.60 feet north of the south east corner thereof; thence West perpendicularly to said East line, 114.58 feet to the point of intersection with a line which is 22.50 feet East of and parallel with the West line of the South portion of said Lot A; thence North along said parallel line and said line extended, 24.605 feet; thence West along a line drawn perpendicularly to the East line of said Lot, 55.52 feet, more or less, to a point on the West line of the North portion of said Lot; thence North along said West line to the North West corner of said lot; thence East along the North line of said Lot to the North East corner thereof; thence South along the East line of said Lot to the point of beginning; said Lot A being a consolidation of Lots 1 and 2 in Block 2, Potter Palmer's Lake Shore Drive Addition to Chicago in the North ½ of Block 7 and part of Lot 21 in Collins' subdivision of the South ½ of block 7 in Canal Trustee's subdivision of the South fractional ¼ of Section 3, Township 39 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois, which survey is attached as Exhibit "A" to Declaration of Condominium made by Amalgamated Trust and Savings Bank, as Trustee under Trust Agreement dated August 18, 1976, and known as Number 3068, recorded in the Office of the Recorder of Cook County, Illinois as Document Number 23675016; together with an undivided percentage interest in the property described in said Declaration of Condominium aforesaid, (excepting from said Parcel all the property and space comprising all the units thereof as defined and set forth in said declaration and survey) in Cook County, Illinois.
