SECOND MORTGAGE

(Home Equity Conversion)

THIS MORTGAGE ("Security Instrument" or "Second Security Instrument" is given on SEPTEMBER 10, 2004. The mortgagor is NANCY J. SCHROEDER, whose address is 164 BAS SWOOD DRIVE, ELK GROVE VILLAGE, ILLINOIS 60007 ("Borrower"). This Security Instruments given to the Secretary of Housing and Urban Development, and whose address is 451 Seventh Street, S.W., Washington, DC 20410 ("Lender") or ("Secretary"). Borrower has agreed to repay to Lender amounts which hender is obligated to advance, including future advances, under the terms of a Home Equity Conversion Loan Agreement Gated the Same date as this Security Instrument ("Loan Agreement"). The agreement to repay is evidenced by Borrower's Note dated the Same date as this Security Instrument ("Second Note"). TOGETHER WITH all the improvements now or hereafter erected on the property, and all easements, rights, appurements and fixtures now or hereafter a part of the property. All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveved and has the right to grant and convey the Property and that the Property is only encumbered by a First Security Instrument given by Borrower and dated the Same date as this Security Instrument ("First Security Instrument"). Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

This insurance shall be maintained in the amounts, to the **extent** and **for** the **periods** required by **Lender**. **Borrower** shall also **insure all** improvements on the **Property**, whether now in existence or **subsequently** erected, against loss by floods to the **extent** required by Lender. The insurance policies and any renewals shall be held by Lender and **shall** include loss payable clauses in favor of, and in a form acceptable to, Lender.

In the event of foreclosure of this Security Instrument or other transfer of title to the Property that extinguishes the indebtedness, all right, title and interest of Borrower in and to insurance policies in force shall pass to the purchaser.

4. Occupancy, Preservation, Maintenance and Protection of the Property; Borrower's Loan Application; Leaseholds. Borrower shall occupy, establish, and use the Property as Borrower's principal residence after the execution of this Security Instrument and Borrower (or at least one Borrower, of initially more than one person are Borrowers) and shall continue to occupy the Property as Borrower's principal residence for the term of the Security Insurance. If the title evidence indicates that the Property is not encumbered by any liens (except the First Security Instrument described in Paragraph 13(a), this Second Security Instrumentand any subordinate Liens that the Lender determines will also be subordinate to any future loan advances), Lender shall request the Borrower to execute such documents.
