

## ORDINANCE NO. 3134

### AN ORDINANCE ANNEXING PROPERTY PURSUANT TO 65 ILCS 5/7-1-13

**PERMANENT INDEX NUMBERS: 29-19-104-029-0000; 29-19-104-030-0000;  
29-19-104-050-0000; 29-19-105-025 to and including 29-19-105-028-0000;

**WHEREAS**, the City of Harvey, Cook County, Illinois wishes to annex certain territory to the City;  
and

**WHEREAS**, the said territory is less than sixty (60) acres in size; and

**WHEREAS**, the said territory is not within the corporate limits of any municipality, but is wholly bounded by one or more municipalities including the City of Harvey; and

**WHEREAS**, legal notices regarding the intention of the City to annex said territory have been published in a newspaper of general circulation within said territory and have been sent to all public bodies required to receive such notice by State statute; and

**WHEREAS**, all documents and other necessary legal requirements are in full compliance with the statutes of the State of Illinois, specifically Chapter 65, paragraph 5/7-1-13 of the Illinois Compiled Statutes; and

**WHEREAS**, it is in the best interests of the City of Harvey that said territory be annexed thereto.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Harvey, Cook County, Illinois, as follows:

**SECTION 1:** That the following described territory:


