That on July 10, 2002, said Contractor made a subcontract with Claimant, authorized and knowingly permitted by said Owners, to provide labor, materials and equipment to complete the concrete for and in said improvement in the amount of One Hundred Ninety-five Thousand Four Hundred Seventy-three Dollars (\$195,473.00) for improvement of said premises.

That at the special instance and request of Contractor, the Claimant furnished extra and additional materials at and extra labor on said premises at the value of Sixty-eight Thousand Eight Hundred Twenty-five and 96/100 Dollars (\$68,825.96), such amount having been approved by Owners or Owners' agents.

That on May 10, 2004, the Claimant completed all the work thereunder that was required to be done by said subcontract.

As of the date hereof, Claimant has completed work having a value of Two Hundred Sixty Four Thousand Two Hundred Ninety-eight and 96/100 Dollars (\$264,298.96).
