#### **MORTGAGE**

This Mor'gage ("Mortgage") is made as of this 1st day of April, 2003, by STRUBE CELERY AND VEGETABLE COMPANY, an Illinois corporation ("Mortgager") to MB FINANCIAL BANK, N.A. ("Mortgager"), and pertains to the real estate described in Exhibit "A," which is attached hereto and hereby made a part hereof.

## ARTICLE 1 RECITALS

Mortgagor has executed and delivered to Mortgagee a Note in the principal sum of THREE MILLION ONE HUNDRED EIGHTY-SEVEN THOUSAND TWO HUNDRED AND 00/100 DOLLARS (\$3,187,200.00) ("Strube Note") dated March 21, 2002. FIVE A DAY LLC, an Illinois limited liability company ("Company") has executed and delivered to Mortgagee a Note in the principal sum of ONE MILLION FIFTY-FIVE THOUSAND TWO HUNDRED NINETY-FOUR AND 08/100 DOLLARS (\$1,055,294.08) ("Company Note") (the Company Note and the Strube Note collectively referred to as the "Note") dated March 21, 2002. The Note bears interest and is payable and due as set forth in the Note. The collective indebtedness evidenced by the Note shall be deemed the "Loan". As of April 1, 2003, Mortgagor and Mortgagee executed a Loan Modification Agreement ("Loan Modification Agreement"), which arrended the Loan Agreement (defined below). Mortgagor agreed to execute and record this Mortgage, pursuant to the Loan Modification Agreement.

## ARTICLE 2 THE GRANT

NOW, THEREFORE, to secure the payment of the outstanding principal indebtedness under the Note and interest and premiums, if any, on the outstanding principal indebtedness under the Note (and all replacements, renewals and extensions thereof, in whole or in part), and to secure the payment of all other sums which may be at any time due and owing or required to be paid under the Note or this Mortgage, or the Loan Agreements of an even date herewith executed in connection with the Strube Note and the Company Note (collectively "Loan Agreement") by and between Mortgagor, and/or the Company and Mortgagee and to secure the performance and observance of

all the covenants, agreements and provisions contained in this Mortgage, the Note, the Loan Agreement or any other agreement made in connection with the Loan (the Mortgage, the Note, the Loan Agreement and such other agreements are collectively the "Loan Documents"), and to secure the performance by Mortgagor under the Loan Documents, and to charge the properties, interests and rights hereinafter described with such payment, performance and observance, and for other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the Mortgagor DOES HEREBY GRANT, REMISE, RELEASE, ALIEN, WARRANT, MORTGAGE AND CONVEY unto Mortgagee, its successors and assigns forever, the land located in the State of Illinois and legally described in Exhibit "A" attached hereto and made a part hereof (the "Premises"), and the following described property, rights and interests (which, together with the Premises, are referred to herein collectively as the "Mortgaged Property"), all of which property, rights and interests are hereby pledge i primarily and on a parity with the Premises, and not secondarily:

- (a) All mildings and other improvements of every kind and description now or hereafter situated, crected or placed thereon and all Mortgagor's materials intended for construction, reconstruction, alteration, and repair of such improvements now or hereafter erected thereon, all of which materials shall be deemed to be included within the Mortgaged Property immediately upon the delivery thereof to the Premises;
- (b) All right, title, and interest of Mortgagor, including any after-acquired title or reversion, in and to the beds of the ways, streets, avenues, sidewalks, and alleys adjoining the Premises;
- (c) Each and all of the tenements, hereditaments, easements, appurtenances, passages, waters, water courses, riparian rights, other rights, liberties, and privileges of the Premises or in any way now or hereafter apportaining thereto, including homestead and any other claim at law or in equity, as well as any after-acquired title, franchise, or license and the reversions and remainders thereof;
- (d) All rents, issues, deposits, royalties, revenues, income and profits accruing and to accrue from the Premises and the avails thereof;
- (e) All fixtures and personal property now or hereafter owned by Mortgagor, attached to or contained in and used or useful in connection with the Premises or the aforesaid improvements thereon, including without limitation any and all air conditioners, antennae, appliances, apparatus, awnings, basins, bathtubs, boilers, bookcases, cabinets, carpets, coolers, curtains, dehumidifiers, disposals, doors, drapes, dryers, ducts, dynamos, elevators, engines, equipment, fans, fittings, floor coverings, furnaces, furnishings, furniture, hardware, heaters, humidifiers, incinerators, lighting, machinery, motors, ovens, pipes, plumbing, pumps, radiators, ranges, recreational facilities, refrigerators, screens, security systems, shades, shelving, sinks, sprinklers, stoves, toilets, ventilators, wall coverings, washers, windows, window coverings,

wiring, and all renewals or replacements thereof or articles in substitution therefor, whether or not the same be attached to such improvements, it being intended, agreed, and declared that all such property owned by Mortgagor and placed by it on the Premises and used in connection with the operation or maintenance thereof shall, so far as permitted by law, be deemed for the purpose of this Mortgage to be part of the real estate constituting and located on the Premises and covered by this Mortgage, and as to any of the aforesaid property that is not part of such real estate or does not constitute a "fixture," as such term is defined in the Uniform Commercial Code (the "Code") of the state in which the Premises are located, this Mortgage shall be deemed to be, as well, a security agreement under the Code for the purpose of creating hereby a security interest in such property, which Mortgagor hereby grants to the Mortgagee as "secured party," as such term is defined in such Code;

- All proceeds of the foregoing, including without limitation all judgments, awards of damage; and settlements hereafter made resulting from condemnation proceedings or the taking of the Premises or any portion thereof under the power of eminent domain, any proceeds of any policies of insurance maintained with respect to the Premises, or proceeds of any sale, option or contract to sell the Premises or any portion thereof; and subject to the terms of this Mortgage and the other Loan Documents, Mortgagor hereby authorizes, directs and empowers Mortgagee, at its option, on behalf of Mortgagor, or the successors or assigns of Mortgagor, to adjust, compromise, claim, collect and receive such proceeds, to give proper receipts and acquittances therefor, and, after deducting expenses of collection, to apply the net proceeds as credit upon any portion, as selected by Mortgagee, of the Loan, notwithstanding the fact that the same way not be due and payable or that the Loan is otherwise adequately secured; and
- All right, title and interest of Mortgagor in and ic any leases now or hereafter on or affecting the Premises, whether oral or written, together with all security therefor and all monies payable thereunder, subject, however to the terms of that certain Assignment of Leases and Rents with respect to the recruises of an even date herewith ("Assignment") executed by Mortgagor to and for the benefit of Mortgagee, and to the conditional permission hereinabove given to Mortgagor to collect rentals under any lease.

To have and to hold the same unto Mortgagee and its successors and assigns forever, for the purposes and uses herein set forth.

If and when the principal amount of the Note and all interest as provided thereunder and any and all other amounts required under the Loan Documents have been paid in full, and all of the agreements contained in the Loan Documents have been performed, then this Mortgage shall be released at the cost of Mortgagor, but otherwise shall remain in full force and effect.

## ARTICLE 3 GENERAL AGREEMENTS

- 3.1 **Principal and Interest**. Mortgagor shall pay promptly when due the principal and interest on the indebtedness evidenced by the Strube Note at the times and in the manner provided in the Strube Note, this Mortgage, or any of the other Loan Documents.
- 3.2 Other Payments. Unless waived in writing by Mortgagee, Mortgagor shall deposit with Mortgagee or a depositary designated by Mortgagee, in addition to the monthly installments required by the Note, monthly until the principal indebtedness evidenced by the Note is paid:
  - (a) A sum equal to all real estate taxes and assessments ("taxes") next due on the Mortgaged Property, all as reasonably estimated by Mortgagee, divided by the whole number of months to elapse before the month prior to the date when such taxes will become due and payable; and
  - (b) Installments representing pro rata portions of the premium or premiums that will become due and payable to renew the insurance as required in Paragraph 3.5 hereof, each such installment to be in such an amount that the payment of approximately equal installments will result in the accumulation of a sufficient sum of money to pay renewal premiums for such insurance at least one (1) month prior to the expiration or renewal date or dates of the policy or policies to be renewed.

All such payments described in this Paragraph 3.2 shall be held by Mortgagee or a depositary designated by Mortgagee, in trust. If the funds so deposited are insufficient to pay, when due, all taxes and premiums as aforesaid, Mortgagor shall, within ten (10) days after receipt of written demand therefor from Mortgagee or its agent, deposit such additional funds as may be necessary to pay such taxes and premiums. If the funds so deposited exceed the amounts required to pay such items, the excess shall be applied on a subsequent deposit or deposits or returned to Mortgagor upon payment in full of all indebtedness under the Note.

Neither Mortgagee nor any such depositary shall be liable for any fairing to make such payments of insurance premiums or taxes unless Mortgagor, while not in default hereunder, has requested Mortgagee or such depositary, in writing, to make application of such deposits to the payment of particular insurance premiums or taxes, accompanied by the bills of such insurance premiums or taxes; provided, however, that Mortgagee may, at its option, make or cause such depositary to make such application of the aforesaid deposits without any direction or request to do so by Mortgagor.

3.3 **Property Taxes**. Mortgagor shall pay immediately, when first due and owing, all general taxes, special taxes, special assessments, water charges, sewer charges, and any other charges that may be asserted against the Mortgaged Property or any part thereof or interest therein, and shall furnish to Mortgagee duplicate receipts therefor within ten (10) days after payment thereof.

Provided, however, that if the monthly deposits required by Paragraph 3.2(a) and (b) hereof is then in effect, Mortgagee, at its option, prior to the occurrence of a Default (as defined in Paragraph 4.1) either shall make such deposits available to Mortgagor for the payments required under this Paragraph 3.3 or shall make such payments on behalf of Mortgagor. Mortgagor may, in good faith and with reasonable diligence, contest the validity or amount of any such taxes or assessments, provided that:

- (a) Such contest has the effect of preventing the collection of the tax or assessment so contested and the sale or forfeiture of the Mortgaged Property or any part thereof or interest therein to satisfy the same;
- (b) Mortgagor has notified Mortgagee in writing of the intention of Mortgagor to contest the same before any tax or assessment has been increased by any interest, penalties, or costs; and
- Mortgagor has deposited with Mortgagee, at such place as Mortgagee may from time to time in writing designate, a sum of money or other security reasonably acceptable to Mortgagee that, when added to the monies or other security, if any, deposited with Mortgagee pursuant to Paragraph 3.2 hereof, is sufficient, in Mortgagee's reasonable judgment, to pay in full such contested tax and assessment and all penalties and interest that might become due thereon, and shall keep on deposit an amount sufficient, in Mortgagee's reasonable judgment, to pay in full such contested tax and assessment, increasing such amount to cover additional penalties and interest whenever, in Mortgagee's reasonable judgment, such increase is advisable.

In the event Mortgagor fails to prosecute such contest with reasonable diligence or fails to maintain sufficient funds on deposit as hereinabove provided, Mortgagor ray, at its option, apply the monies and liquidate any securities deposited with Mortgagee in payment of or on account of, such taxes and assessments, or any portion thereof then unpaid, including all penaities and interest thereon. If the amount of money and any such security so deposited is insufficient for the payment in full of such taxes and assessments, together with all penalties and interest thereon, Mortgagor shall forthwith, upon demand, either deposit with Mortgagee a sum that, when added resuch funds then on deposit, is sufficient to make such payment in full, or, if Mortgagee has applied funds on deposit on account of such taxes and assessments, restore such deposit to an amount reasonatary satisfactory to Mortgagee in accordance with the terms of Paragraph 3.2 herein. Provided that Mortgagor is not then in default hereunder or under the Note, Mortgagee shall, if so requested in writing by Mortgagor, after final disposition of such contest and upon Mortgagor's delivery to Mortgagee of an official bill for such taxes, apply the money so deposited in full payment of such taxes and assessments of that part thereof then unpaid, together with all penalties and interest thereon.

3.4 Tax Payments by Mortgagee. Mortgagee is hereby authorized to make or advance, in the place and stead of Mortgagor, any payment relating to taxes, assessments, water and sewer charges, and other governmental charges, fines, impositions, or liens that may be asserted against

the Property, or any part thereof, and may do so according to any bill, statement, or estimate procured from the appropriate public office without inquiry into the accuracy thereof or into the validity of any tax, assessment, lien, sale, forfeiture, or title or claim relating thereto. Mortgagee is further authorized to make or advance, in the place and stead of Mortgagor, any payment relating to any apparent or threatened adverse title, lien, statement of lien, encumbrance, claim, charge, or payment otherwise relating to any other purpose herein and hereby authorized, but not enumerated in this Paragraph 3.4, whenever, in its judgment and discretion, such advance seems necessary or desirable to protect the full security intended to be created by this Mortgage. In connection with any such advance, Mortgagee is further authorized, at its option, to obtain a continuation report of title or title insurance policy prepared by a title insurance company of Mortgagee's choosing. All such advances and indebtedness authorized by this Paragraph 3.4 shall constitute additional indebtedness secured hereby and shall be repayable by Mortgagor upon demand with interest at the "Default Rate" (as that term is defined in the Note).

- 3.5 **Insurate:** Mortgagor will insure the Mortgaged Property against such perils and hazards, and in such amounts and with such limits, as Mortgagee may from time to time require, and in any event will continuously maintain the following described policies of insurance (the "Insurance Policies"):
  - (a) Casualty Insurance in an amount equal to the full replacement cost of the Mortgaged Property; and
  - (b) Comprehensive public liability against death, bodily injury and property damage; and
  - (c) If the Premises has been designated to be in a special flood hazard area, first and second layer flood insurance when and as available.

In the event Mortgagor has not maintained or procured the policies of insurance required above, in addition to all other remedies of Mortgagee hereunder in the event of a Default Mortgagee may, at any time thereafter and in its sole discretion, procure and substitute for any and all of the policies of insurance required above, such other policies of insurance, in such amounts, and carried in such companies, as it may reasonably select, and in such event, those policies of insurance shall be included within the definition of "Insurance Policies" set forth herein.

All Insurance Policies shall be in form, companies and amounts reasonably satisfactory to Mortgagee. All Insurance Policies insuring against casualty, rent loss and business interruption and other appropriate policies shall include non-contributing mortgagee endorsements in favor of and with loss payable to Mortgagee, as well as standard waiver of subrogation endorsements, shall provide that the coverage shall not be terminated or materially modified without thirty (30) days' advance written notice to Mortgagee and, provided Mortgagor can obtain the same, shall provide that no material claim shall be paid thereunder without ten (10) days' advance written notice to Mortgagee. Mortgagor will deliver all Insurance Policies or certificates of insurance for Insurance Policies with premium prepaid to Mortgagee and, in case of Insurance Policies about to expire,

Mortgagor will deliver renewal or replacement policies or certificates not less than thirty (30) days prior to the date of expiration. The requirements of the preceding sentence shall apply to any separate policies of insurance taken out by Mortgagor concurrent in form or contributing in the event of loss with the Insurance Policies. In the event of foreclosure of the Mortgage or assignment hereof by Mortgagee or transfer of title to the Mortgaged Property, all right, title and interest of Mortgagor in and to the policies then in force shall pass to the Mortgagee, purchaser, grantee or assignee.

- (d) Upon the occurrence of a "Major Casualty" (as hereinafter defined):
  - (1) Full power is hereby conferred on Mortgagee:
    - a. to settle and compromise all claims under all policies;
    - b. to demand, receive and receipt for all monies becoming due and/or payable under all policies;
    - c. to execute, in the name of Mortgagor or in the name of Mortgagee, ary proofs of loss, notices or other instruments in connection with all claims under all policies; and
    - d. to assign al. policies in the event of the foreclosure of this Mortgage or other transfer of title to the Mortgaged Property.
  - In the event of payment unaction of the policies, the proceeds of the policies shall be paid by the insurer to Mortgagee and, Mortgagee, in its sole and absolute discretion, may apply such proceeds, wholly or partially, after deducting all costs of collection, including reasonable attorneys' fees either (i) toward the alteration, reconstruction repair or restoration of the Mortgaged Property or any portion thereof, c. (ii) as a payment on account of Mortgagor's liability under the Loan (without attecting the amount of time of subsequent payments required to be made by Mortgagor under the Note), whether or not then due and payable.
- (e) Upon the occurrence of a fire or other casualty to the Mortgaged Property, whether or not such fire or other occurrence shall constitute a Major Casualty, and notwithstanding any provision to the contrary contained in this Mortgage, Mortgagor shall restore the improvements on the Mortgaged Property provided Mortgagee applies the proceeds as set forth in Paragraph 3.5(a)(2)(i) above, whereupon all proceeds for rebuilding or restoring the improvements shall be deposited by the insurance carrier into an account (the "Escrow") at a title insurance and escrow company acceptable to Mortgagee (the "Title Company") pursuant to an Escrow Trust Agreement between Mortgagor, Mortgagee, and the Title Company which insures that the proceeds are disbursed only as work is completed to the Mortgaged

Property and only after a review of the condition of title to the Property by the Title Company verifying that (i) the title policy issued to Mortgagee in connection with the Loan is continued through the date of such disbursement with certification over mechanic lien claims in the amount of the proceeds disbursed to date and (ii) no exceptions to title arise that are asserted to be superior to the lien of this Mortgage.

No payment made prior to the final completion of the restoration, repair, replacement and rebuilding shall exceed ninety percent (90%) of the value of the work performed from time to time, as such value shall be determined by Mortgagee in its sole and exclusive judgment. The funds deposited into the Escrow shall be sufficient at all times to complete the restoration. If the funds become insufficient during the course of the reconstruction to complete the restoration, Mortgagor shall within ten (10) days of notice from the Title Company or Mortgagee of the deficiency, deposit the amount of the deficiency into the Escrow. The provisions of the Escrow shall require that all costs associated with the Escrow, including, without limitation, examination of title and issuance of title policy endorsements, shall be paid by the Mortgagor. To the extent otherwise required under this Paragraph 3.5, the Mortgaged Property shall be restored and reconstructed to substantially the same condition and value as before the casualty loss. The reconstruction and rebuilding shall be in compliance with all applicable building codes, environmental obligations and zoning ordinances.

For purposes of this Agreement, a 'Major Casualty" shall be deemed to consist of the following: (i) a fire or other casualty loss to the Mortgaged Property, if hereafter improved, that results in damage to the Mortgaged Property of \$50,000.00 or more in the opinion of a licensed architect or engineer reasonably acceptable to Mortgagee or (ii) a fire or other casualty loss to the Mortgaged Property necessitating reconstruction or rebuilding that (a) in the opinion of a licensed architect or engineer reasonably acceptable to Mortgagee cannot be completed within three (3) months from the date of such casualty loss, or (b) the repair (a) which will result in a material alteration in the configuration, design or appearance of the Mortgage 1 Property.

3.6 Condemnation and Eminent Domain. Any and all awards he retofore or hereafter made or to be made to the present, or any subsequent, owner of the Mortgage Property, by any governmental or other lawful authority for the taking, by condemnation or eminent domain, of all or any part of the Mortgaged Property, any improvement located thereon, or any easement thereon or appurtenance thereof (including any award from the United States Government at any time after the allowance of a claim therefor, the ascertainment of the amount thereof, and the issuance of a warrant for payment thereof), are hereby assigned by Mortgager to Mortgagee, which awards Mortgagee is hereby authorized to collect and receive from the condemnation authorities, and Mortgagee is hereby authorized to give appropriate receipts and acquittances therefor. Mortgagor shall give Mortgagee immediate notice of the actual or threatened commencement of any condemnation or eminent domain proceedings affecting all or any part of the Premises, or any easement thereon or appurtenance thereof (including severance of, consequential damage to, or change in grade of streets), and shall deliver to Mortgagee copies of any and all papers served in

connection with any such proceedings. Mortgagor further agrees to make, execute, and deliver to Mortgagee, at any time upon request, free, clear, and discharged of any encumbrance of any kind whatsoever, any and all further assignments and other instruments deemed necessary by Mortgagee for the purpose of validly and sufficiently assigning all awards and other compensation heretofore and hereafter made to Mortgagor for any taking, either permanent or temporary, under any such proceeding. At Mortgagee's option, reasonably exercised, any such award may be applied to restoring the improvements, in which event the same shall be paid out in the same manner as is provided with respect to insurance proceeds in Paragraph 3.5.

3.7 Maintenance of Property. Subject in all instances to the terms of Paragraphs 3.5 and 3.6 hereof, Mortgagor shall promptly repair, restore, or rebuild any building or other improvement now or hereafter situated on the Premises that may become damaged or destroyed. Any such building or other improvement shall be so repaired, restored, or rebuilt so as to be of at least equal value and of substantially the same character as prior to such damage or destruction.

Mortgager further agrees to permit, commit, or suffer no waste, impairment, or deterioration of the Mortgaged Property or any part thereof other than ordinary wear and tear repaired in accordance with the terms hereof; to keep and maintain the Mortgaged Property and every part thereof in good repair and condition; to effect such repairs as Mortgagee may reasonably require, and, from time to time, to make all necessary and proper replacements thereof and additions thereto so that all of the Premises and such buildings other improvements, fixtures, chattels, and articles of personal property will, at all times, be in good condition, fit and proper for the respective purposes for which they were originally erected or installed.

- 3.8 Compliance with Laws. Mortgago shall comply with all statutes, ordinances, regulations, rules, orders, decrees, and other requirements relating to the Mortgaged Property or any part thereof by any federal, state, or local authority; and shall observe and comply with all conditions and requirements necessary to preserve and extend any and all rights, licenses, permits (including without limitation zoning variances, special exceptions, nonconforming uses, environmental and pollution laws, statutes, ordinances and regulations), privileges, franchises, and concessions that are applicable to the Mortgaged Property or that have been granted to or contracted for by Mortgagor in connection with any existing or presently contemplated use of the Property.
- 3.9 Liens and Transfers. Without Mortgagee's prior written consent, no tgagor shall not create, suffer, or permit to be created or filed against the Mortgaged Property or any part thereof, any mortgage lien or other lien superior or inferior to the lien of this Mortgage, provided that Mortgagor may, within ten (10) days after the filing thereof, contest any lien claim arising from any work performed, material furnished, or obligation incurred by Mortgagor upon furnishing Mortgagee security and indemnification reasonably satisfactory to Mortgagee for the final payment and discharge thereof. In the event Mortgagor hereafter otherwise suffers or permits any superior or inferior lien to be attached to the Mortgaged Property or any part thereof without Mortgagee's consent, Mortgagee shall have the unqualified right, at its option, to accelerate the maturity of the

Note, causing the entire principal balance thereof and all interest accrued thereon to be immediately due and payable, without notice to Mortgagor.

Mortgagor shall not, without the prior written consent of Mortgagee, create, effect, consent to, suffer or permit any "Prohibited Transfer" (as defined herein). Any conveyance, sale, assignment, lease, transfer, lien, pledge, mortgage, security interest or other encumbrance or alienation (or any agreement to do any of the foregoing) of any of the following properties, rights or interests which occurs, is granted, accomplished, attempted or effectuated without the prior written consent of Mortgagee shall constitute a "Prohibited Transfer":

- (a) The Mortgaged Property;
- (b) All or any portion of the beneficial interest or power of direction in or to the trust under which Mortgagor is acting if Mortgagor is a land trust;
- (c) A controlling interest of capital stock of Mortgagor if Mortgagor is a corporation except a transfer to a trust of which the Transferor is trustee and beneficiary during his lifetime;
- (d) All or any part of any general partnership or joint venture interest or membership interest, as the case may be, of Mortgagor if Mortgagor is a partnership or a joint venture or a limited liability (ompany;

in each case whether any such conveyance, sale, assignment, transfer, lien, pledge, mortgage, security interest, encumbrance or alienation is effected directly, indirectly, voluntarily or involuntarily, by operation of law or otherwise.

Any waiver by Mortgagee of the provisions of this Parag arh 3.9 shall not be deemed to be a waiver of the right of Mortgagee in the future to insist upon strict compliance with the provisions hereof.

Notwithstanding anything to the contrary contained herein, any "Perfolited Transfer" (as defined in the Loan Agreement) shall not be deemed a Prohibited Transfer herein.

- 3.10 Subrogation to Prior Lienholder's Rights. If the proceeds of the Loan secured hereby, any part thereof, or any amount paid out or advanced by Mortgagee are used directly or indirectly to pay off, discharge, or satisfy, in whole or in part, any prior lien or encumbrance upon the Mortgaged Property or any part thereof, then Mortgagee shall be subrogated to the rights of the holder thereof in and to such other lien or encumbrance and any additional security held by such holder, and shall have the benefit of the priority of the same.
- 3.11 Mortgagee's Dealings with Transferee. In the event of the sale or transfer, by operation of law, voluntarily, or otherwise, of all or any part of the Mortgaged Property, Mortgagee

  - (1) Mortgagor shall file a voluntary petition in bankruptcy or for arrangement, reorganization or other relief under any chapter of the Federal Bankruptcy Act or any similar law, state or federal, now or hereafter in effect;
  - (2) Mortgagor shall file an answer or other pleading in any proceeding admitting insolvency, bankruptcy, or inability to pay its debts as they mature;
  - Within fixty (60) days after the filing against Mortgagor of any involuntary proceeding under the Federal Bankruptcy Act or similar law, state or federal, now or hereafter in effect, such proceedings shall not have been vacated;
  - (4) All or a substantial part of any Mortgagor's assets are attached, seized, subjected to a writ or distress warrant, or are levied upon;
  - (5) Mortgagor shall be adjudicated a bankrupt;
  - (6) Mortgagor shall make an assignment for the benefit of creditors or shall admit in writing its inability to pay its debts generally as they become due or shall consent to the appointment of a receiver or trustee or liquidator of all or the major part of its property, or the Premises:
  - (7) Any order appointing a receiver, trustee or liquidator of any Mortgagor or a major part of Mortgagor's property or the Premises;
  - (8) Any individual Mortgagor shall die, be adjudicated as incorrectent, or any Mortgagor shall be dissolved, terminated or merged;
