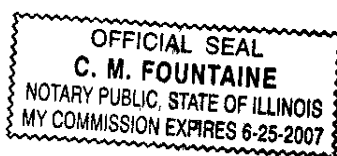

### 3. Legal Description:

#### Parcel 1:
