#### Memorandum of Agreement

This Memorandum of Agreement ("Memorandum") dated Sept. 14, 2007, evidences that a lease was made and entered into by a written Site Agreement (the Agreement") dated Sept. 14, 2007, between The Catholic Bishop of Chicago, a corporation sole ("Owner") and Sprint Corn, Inc., a Kansas Corporation ("Sprint").


