- A. Maximum Obligation Limit. The maximum obligation provision of the Security Instrument is modified to read:
  - (1) Maximum Obligation Limit. The total principal amount secured by this Security Instrument at any one time will not exceed \$2,000,000.00. This limitation of amount does not include interest, attorneys' fees and other fees and charges validly made pursuant to this Security Instrument. Also, this limitation does not apply to advances made under the terms of this Security Instrument to protect Lender's security and to perform any of the covenants contained in this Security Instrument.
- B. Secured Debt. The secured debt provision of the Security Instrument is modified to read:
  - (1) Secured Debts. This Security Instrument will secure the following Secured Debts:
    - (a) Specific Debts. The following debts and all extensions, renewals, refinancings, modifications and replacements. A promissory note or other agreement, No. 6047109-01, dated March 19, 2003, from Portage Run, LLC, Lakeside Bank, as trustee, under Trust Agreement dated March 17, 2003 and known as Trust Number 10-2503, John J. Keich, Christine A. Keich and Brownstone Prope ties, Inc. (Borrower) to Lender, with a loan amount of \$2,000,000.00, with an initial variable interest rate of 5.5 percent per year until September 9, 2004, after which time it may change as the promissoly note prescribes and maturing on December 19, 2004.
    - (b) All Debts. All present and future debts from Portage Run, LLC, Lakeside Bank, as trustee, under Trust Agreement dated March 17, 2003 and known as Trust Number 10-2503, John J. Keich, Christine A. Keich and Brownstone Properties, Inc. to Lender, even if this Security Instrument is not specifically referenced, or if the future debt is unrelated to or of a different type than this debt. If more than one person signs this Security Instrument, each agrees that it will secure debts incurred either individually or with others who may not sign this Security Instrument. Nothing in this Security Instrument constitutes a commitment to make additional or future loans or advances. Any such commitment must be in writing. In the event that Lender fails to provide any required notice of the right of rescission, Lender waiver any subsequent security interest in the Mortgagor's principal dwelling that is created by this Security Instrument. This Security Instrument will not secure any debt for which a non-possessory, non-purch ase money security interest is created in "household goods" in connection with a "consumer loar," as those terms are defined by federal law governing unfair and deceptive credit practices. This Security Instrument will not secure any debt for which a security interest is created in "margin stock" and Lender does not obtain a "statement of purpose," as defined and required by federal law governing securities.
    - (c) Sums Advanced. All sums advanced and expenses incurred by Lender under the terms of this Security Instrument.
- 3. CONTINUATION OF TERMS. Except as specifically amended in this Modification, all of the terms of the Security Instrument shall remain in full force and effect.
