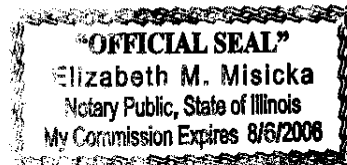

EXHIBIT "A"

Parcel One:

That part of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 22, Township 41 North, Range 9 East of the Third Principal Meridian, described as follows: beginning at a point in the north line of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of said Section 22, 95.7 feet east of the northwest corner of said Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$; thence east along said north line 205.0 feet; thence south parallel to said east line of State Bond Issue Route 59 to a point in the north line of Chicago-Elgin Road as originally laid out; thence westerly along said north line of the Chicago-Elgin Road as originally laid out to its intersection with the east line of said Route 59; thence northerly along said east line to place of beginning; and

Parcel Two:

That part of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 22, Township 41 North, Range 9 East of the Third Principal Meridian, described as follows: commencing at a point in the north line of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of said Section 22, 95.7 feet east of the northwest corner of said Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$; thence easterly along the north line of said Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$, 205.0 feet from the place of beginning; thence southerly parallel with the east right of way line of State Route 59, 478.0 feet to the center line of Irving Park Boulevard; thence easterly along said center line, being along a curve to the left, 134.89 feet; thence northerly parallel with the east right of way line of State Route 59, a distance of 499.63 feet to a point on the north line of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of said Section 22 that is 133.72 feet easterly of (measured along said north line of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of said Section 22) the place of beginning; thence westerly along said north line, a distance of 133.72 feet to the place of beginning, all of said Parcel 1 and all of said Parcel 2 being in Cook County, Illinois.
