### **LOAN MODIFICATION AGREEMENT**

AND WHEREAS, the parties desire to restate the modified terms of said loan so that there shall be no misunderstanding of the matter;

THEREFORE, it is hereby agreed that, as of the date of this Agreement, the unraid balance of said indebtedness is TWO HUNDRED NINETY SIX THOUSAND NINE HUNDRED SEVEN AND SIXTY-THREE CENTS (U.S \$296,907.63), all of which the undersigned promises to pay with interest at 7.50% per annum until paid, and that the same shall be payable TWO THOUSAND TWO HUNDRED ELEVEN AND 25/100 CENTS (U.S \$2,211.25) per month beginning on the 1<sup>st</sup> day of OCTOBER, 2004, to be applied first to interest, and balance to principal, plus a sum estimated to be sufficient to discharge taxes and insurance obligations (if applicable) and that in all other respects said mortgage contract shall remain in full force and effect.
