- 1. Defendant <u>LaSalle Bank</u>, as <u>Trustee or Irust No. 11216-01</u>, and its beneficiary, <u>James Damion</u>, their agents, heirs, successor or assigns, be perminently enjoined and restrained from renting, using, leasing, or occupying the <u>subject building(s) to cated at 8621 S.
