ORDER OF PERMANENT INJUNCTION

The Court having heard evidence and testimony in this cause, and being fully advised in the premises, hereby orders that:

1. Defendant LaSalle Bank, as Trustee of Trust No. 11216-01, and its beneficiary, James Damion, their agents, heirs, successor or assigns, be permanently enjoined and restrained from renting, using, leasing, or occupying the subject building(s) located at 8621 S. Halsted until full compliance with the City of Chicago codes as stated in this cause and further order of court. This property has a PIN of 20-33-314-001, and is legally described as follows:
THAT PART OF LOT 6 LYING EAST OF A LINE 50 FEET EAST OF AND PARALLEL WITH THE WEST LINE OF SECTION 33, TOWNSHIP 38 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN BLOCK 13, IN SOUTH ENGLEWOOD A SUBDIVISION BY SISSON AND NEWMAN OF THAT PORTION LYING WEST AND SOUTHWEST OF THE HOLLAND SETTLEMENT ROAD SOUTH AND SOUTHEAST OF THE VINCENNES ROAD AND EAST OF THE CENTER LINE OF CHICAGO ROCK ISLAND AND PACIFIC RAILROAD OF SECTIONS 32 AND 33, TOWNSHIP AND RANGE AFORESAID, IN COOK COUNTY, ILLINOIS.
2. The court reserves jurisdiction of this matter for the purposes of modification, enforcement, or termination of this permanent injunction.
3. This order is final, appealable, and enforceable, the court finding no just cause or reason to delay its enforcement or appeal.
4. This matter is dismissed subject to this permanent injunction, the mandatory order of compliance entered separately today, and the judgment of \$13,600.00 entered against AMCO Properties entered separately today.
