#### Permitted Exceptions

- (5) leases and licenses affecting the Common Elements;
- (6) Building line 8 feet from Goethe Street, as shown on the Plat of Subdivision of Lots 4, 5, 6 and 7 and vacated alley aforesaid;
- (7) Terms and conditions of the Coveragat recorded May 21, 2001 as Document Number 0010428623 regarding the maintenance and repair of sewer lines;
- (8) Encroachment of the cornice above the 8<sup>rd</sup> floor over the south line onto adjoining property by as much as 1.93 feet more or less at the southwest corner of the building and by as much as 1.88 feet more or less at the southeast corner of the ruilding
