Such on reserve shall be non-refundable, notwithstanding the fact that the Loan is ultimately paid in full, and Len's, shall not be required to pay Borrower any interest or earnings on such loss reserve. Lender can no longer require to s reserve payments if Mortgage Insurance coverage (in the amount and for the period that Lender requires) provided by an insurer selected by Lender again becomes available, is obtained, and Lender requires separately designated payments toward the premiums for Mortgage Insurance. If Lender required Mortgage Insurance as a condition of making the Loan and Borrower was required to make separately designated payments toward the premiums for Mortgage Insurance, Borrower shall pay the premiums required to maintain Mortgage Insurance in effect, or to provide a non-refundable loss reserve, until Lender's requirement for Mortgage Insurance end's in accordance with any written agreement between Borrower and Lender providing for such termination or until ermination is required by Applicable Law. Nothing in this Section 10 affects Borrower's obligation to pay interest at the rate provided in the Note.


