This matter coming to be heard in status on the order of protection, a Don Child's Representative's Petition for Rule to Show Cause ~~and~~ all parties having due notice, the Court being fully advised with the premises,
It is hereby ordered:

- 1) Sonya Diosdado-Carrillo is granted custody of the minor children. Sonya Diosdado-Carrillo must enroll Elyssia Diosdado ~~in appropriate individual counseling~~ ^{as prescribed by her mother} until such time as the therapist determines that such counseling is no longer necessary.
- 2) ~~The~~ Sonya Diosdado-Carrillo shall pay the Child's Representative the sum of \$2,439.75 per proportionate share of the child's Representative fees. Such fees shall be paid by Mrs. Diosdado-Carrillo at the rate of \$200.00 per month, to be paid on or before the 15th day of each month.
- 3) Judgment is entered against Anthony Taylor ~~in~~ ⁱⁿ favor of Sheri C. Kessler in the amount of \$2,439.75 for fees due to the child's representative.
- 4) Sheri C. Kessler is discharged as the child's representative.
- 5) The child shall be evaluated as to her educational abilities through an individual educational assessment to be administered by Prairie Junior High in Alsip, IL, at no cost to the child's parents.
