Purpose of Power

Continuing to Paragraph One (1) Grant of Power, foliowing

1. Grant of Power

I, Vincent F. Lufrano, DO HEREBY NOMINATE AND APPOINT Guyanne Lufrano, as my attorney-in-fact (my "agent") to act for me and in my name (in any way I could act in person) in the exercise of prudent discretion with respect to the following powers and provisions, as defined in Section 3-4 of the "Statutory Short Form Power of Attorney for Property Law," as amended, and as set out in subsections "a)" to "o)" of this paragraph below: a)

Real Estate Transactions

In reference to the phrase "...which I in my own proper person with legal capacity could do personally...." this means, in this and any subsequent paragraph or subsection thereof, that my agent may act as though I was acting in my own proper person had I legal capacity. Were I to be declared impaired or lacking in legal capacity during this Power's term, that fact alone would not constitute a bar against or abridgement of my agent's acts hereunder.

b) Financial Institution Transactions

My agent is authorized to: open, close, continue and control all accounts and deposits in any manner and form as is necessary through the exercise of prudent discretion, in any type of financial institution (which term includes without limitation, banks, trust companies, savings and building and loan associations, credit unions, and brokerage financial institution account or deposit) whether domestic (US or its political subdivisions) or foreign; and, in general, exercise all powers with respect to financial institutes which I in my own proper person with legal capacity could do personally.

c) Stock and Boמd Transactions

My agent is authorized to, prepare, sign, and file any claim or application for Social Security, disability, retirement or any such or like under any State, Cook County or other unit of local government agency(ies,) and other benefits, whether presently or in the future inuring to my benefit; sue for, settle or abandon any claims thereto or of any assistance under any Federal, State, local or foreign jurisdiction, either under statute, rule, regulation or like; control, deposit to any account, collect, receipt for, and take title to and hold all benefits hereunder; and, in general, exercise all powers with respect to Social Security, disability, retirement or pension or like and/or other governmental benefits which I in my own proper person with legal capacity could do personally.

j) Tax Matters

My agent is authorized to: sign, verify and file all my federal, state, and local income, gift, estate, property and other tax returns or tax documents therefor, including but not limited in generality to any and all declarations and/or documents for taxation of crarsforence of real property or interests therein, including joint returns and declarations of estimated tax; pay all taxes, including transfer or taxation stamps or their like affixed to and required for recordation of title or interest in real estate; claim, sue for and receive all tax refunds; examine and copy my tax returns and supporting or necessary documents relating thereto; represent me in person or through retaining counsel in any agency of competent jurisdiction relating to any matter herein; and sign and deliver all tax powers of attorney on my behalf that may be necessary under these premises; waive rights and sign all documents on my behalf hereto to settle, pay or determine and contest any tax liabilities; and, in general, exercise all powers with respect to tax matters which I in my own proper person with legal capacity could do personally.
