AMENDMENT NO. 2 TO MORIGAGE AND SECURITY AGREEMENT – NICOLA NITTI

Amendment No. 2 to Mortgage dated as of September 19th, 2004, is made by NICOLA NITTI ("Mortgagor") in favor of ROUTE 176, L.L.C. ("Mortgager"). This Amendment pertains to the real estate described on Exhibit "A" attached hereto and made a part hereof.

- 1. Section 1.01 is hereby deleted in its entirety and replaced by the following:
 - "1.01 Note. Mortgagor has executed in connection herewith that certain secured note dated the date of this mortgage, as may from time to time be amended, modified, substituted, restated, renewed and/or extended, in the original principal amount of \$64,200.00 in favor of Mortgagee which was amended by that certain Amendment No. 2 to Note increasing the principal amount of the secured note to \$66,793.68 (together the secured note and the amendments thereto shall hereinafter be referred to as the "Note")."
- 2. All references in the Mortgage to the Mortgage shall mean the Mortgage as amended by this Amendment and as may be further amended and/or restated from time to time.
- 3. All references in the Mortgage to the Note shall mean the Note, as amended by the Amendment No. 2 to Note and as may be further amended, extended, renewed, supplemented and/or restated from time to time.

In all other respects, the Mortgage is hereby restated, reaffirmed and incorporated herein, the only 4. amendments intended to be made thereto being those above set forth. Except as specifically set forth herein to the contrary, all terms defined in the Mortgage shall have the same meanings herein as therein.
