- Any change of registered agent must be by resolution adopted by the board of directors. This statement must 5. then be signed by a duly authorized officer.
- The registered agent may report a change of the registered office of the corporation for which he or she is registered agent. When the agent reports such a change, this statement must be signed by the registered 6. agent. If a corporation is acting as the registered agent, a duly authorized officer of such corporation must sign this statement.
