

AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP
FOR THE

8000 SOUTH INDIANA CONDOMINIUM

THIS AMENDMENT dated March 23, 2002 is made and entered into by the Board of Directors of the 8000 South Indiana Condominium including the approval of Grace Currin, owner of Unit 127-1 and Unit 127-2.

WITNESSETH:

- 1. WHEREAS, the original Declaration of Condominium Ownership (the "Declaration") dated March 3, 1989 was recorded with the Cook County Recorder of Deeds as Document No. 89114564;
- 2. WHEREAS, the condominium contains Unit 127-1 and 127-2 as delineated and defined in the survey attached to said Declaration; and
- 3. WHEREAS, said Unit 127-1 (PIN 20-34-108-049-1002), and 127-2 (PIN 20-34-108-049-1003) was conveyed to Grace Currin, the present unit owner, in accordance with a copy of the trustee's deed attached hereto as Exhibit "A";
- 4. WHEREAS, said Unit 127-1 and 127-2 is delineated on the survey attached to the Declaration (Document 19114564) as a split level or duplex containing only one dwelling unit;

NOW, THEREFORE, the Board of Directors on March 23, 2002, has duly amended the Declaration to provide that for purposes of real estate taxation, and to reflect its single family use, that only one Permanent Index Number (in place of the present two) should be issued to cover Unit 127-1 and Unit 127-2. In all other respects, Unit 127-1 and Unit 127-2 remain unchanged as delineated on the survey attached to the Declaration. A copy of such amendment to the Declaration providing for consolidating the Permanent Index Numbers is attached hereto as Exhibit "B."
