NOTES

Such certified copies may be obtained ONLY from the Secretary of State.
- 5. Any change of registered agent must be by resolution adopted by the board or directors. This statement must then be signed by a duly authorized officer.
- 6. The registered agent may report a change of the register of office of the corporation for which he or she is registered agent. When the agent reports such a change his statement must be signed by the registered agent. If a corporation is acting as the registered agent, a duty authorized officer of such corporation must sign this statement.
