- 1. <u>Amendment.</u> Exhibit 3 of the Declaration is corrected and amended as set out on Exhibit 3 attached to this second amendment.
- 2. <u>Condominium Instruments</u>. All references in the Declaration to the Condominium Instruments shall hereby be deemed to include this Amendment.
- 3. Terms. All terms used herein, if not otherwise defined herein shall have the meanings set forth in the declaration.
