- 4. Late Payment Fee. Borrower shall pay the Bank a late charge of five percent (5%) of any monthly installment not received by the Bank within fifteen (15) days after the installment is due.

- (c) Annual receipt of income and expense statements for property described herein.
- 6. Reaffirmation of Representations / Continuation of Documents.
  Mortgagor, Borrower and Grantor further agree that all of the stipulations, provisions, conditions and covenants of the above described Note, Mortgage, Assignment of Rents and Collateral Assignment of Beneficial Interest shall remain in till force and effect, except as herein extended and/or modified, and nothing herein shall be construed to impair the security or lien of the Bank in and to the subject premises nor to affect nor impair any rights or powers which Bank may have under said note, mortgage and/or trust deed in any other instrument of document delivered to the Bank by the Mortgagor, Borrower and Grantor.
