4. In the event of the inability, refusal of the Trustee of the Trinity Trust herein named, to act, or upon his removal from the County, **Iris Jeneen Fullilove** is then appointed as Successor Trustee herein with like powers and authority as is vested in the Trustee named herein.

All of the covenants, conditions, powers, rights and duties vested hereby, in the respective parties, shall inure to and be binding upon their heirs, legal representatives and assigns.

If the title to any of the above real estate now is or hereafter shall be registered, the Recorder of Titles is directed not to register or note in the Certificate of Title, duplicate thereof, or memorial, the words "in trust" or "upon condition", or "with limitation" or vords of similar import, in compliance with the Statute of the State of Illinois in such case made and provided.
