RESTITUTION JUDGEMENT ORDER

THIS CAUSE coming to be heard on the regular of the Honorable Judge Rickey Jones, the Court, having subject matter jurisdiction and being fully advised in the premises,

## FINDS:

- 1. The Cook County State's Attorney's Office filed a four count indictment, 02CR-21696, against derendant Joann Toutant, alleging the following offenses: Theft by Unauthorized Control (720 ILCS, Act 5, 16-1a(1)7) and Conspiracy (720 ILCS, Act 5, Sec. 8-2(16-1)(A)-1).
- 2. During proceeding before the Honorable Judge Rickey Jones on defendant Joann Toutant plead guilty to Theft by Unauthorized Control (720 ILCS, Act 5, Sec. 16-1(a)(1)), and the Court entered findings of guilty on that count.
- 3. During those proceeding, defendant Joann Toutant stipulated to a factual basis supporting her plea of guilty to one count of Theft, said factual basis averring that Joann Toutant obtained money from the victim through a fraudulent scheme involving the issuing and cashing checks purportedly made by the authority of the victim, ATC Healthcare Services, Inc and AECHLISTOS, ENC.
- 4. Defendant's conduct, as stipulated to in said factual basis, falls within the definition set forth in 11 USC, Sec. 523(a)(2)(A) "false pretenses, a false representation, or actual fraud..."
