GRANTOR'S WAIVERS. Payment. Notice of Construction. Maintenance of Insurance. (rantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all Improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee claus. In favor of Lender. Policies shall be written by such insurance companies and in such form as may be resonably acceptable to Lender. Grantor shall deliver to Lender certificates of coverage from each insurer containing a stipulation that coverage will not be cancelled or diminished without a minimum of ten (10) days' prior written notice to Lender and not containing any disclaimer of the insurer's liability for failure to give such notice. Each insurance policy also shall include an endorsement providing that coverage in favor of Leider will not be impaired in any way by any act, omission or default of Grantor or any other person. In addition to recording this Mortgage in the real property records, Lender may, at any time and without further authorization from Granfor, file executed counterparts, copies or reproductions of this Mortgage as a financing statement. Granto shall reimburse Lender for all expenses incurred in perfecting or continuing this security interest.
