

3. Notice was published in the Chicago Sun-Times in Chicago, Illinois, from JULY 15, 2004 through JULY 17, 2004.



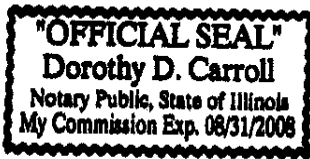
