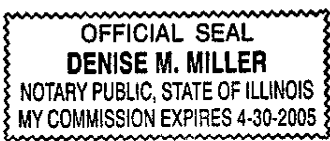

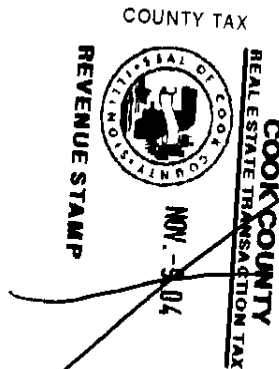
LEGAL DESCRIPTION:

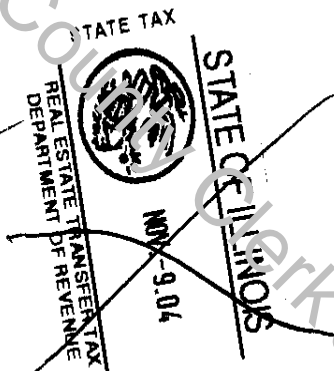
