- 3. 317,475 square feet of Floor Area. For purposes of the foregoing, the definition of Floor Area contained in the Chicago Zoning Ordinance as of the date hereof, as modified by the RBPD #No. 70 and the Master Plan, shall apply.

This letter shall inure to the benefit of Owner, as owner of Parcel E1, and its successors and assigns.

The undersigned acknowledges and agrees that it shall not grant any rights within Subarea E of the Property which would diminish the foregoing development rights allocated to Parcel E1 or would preclude Owner from fully utilizing the above-described development rights.
