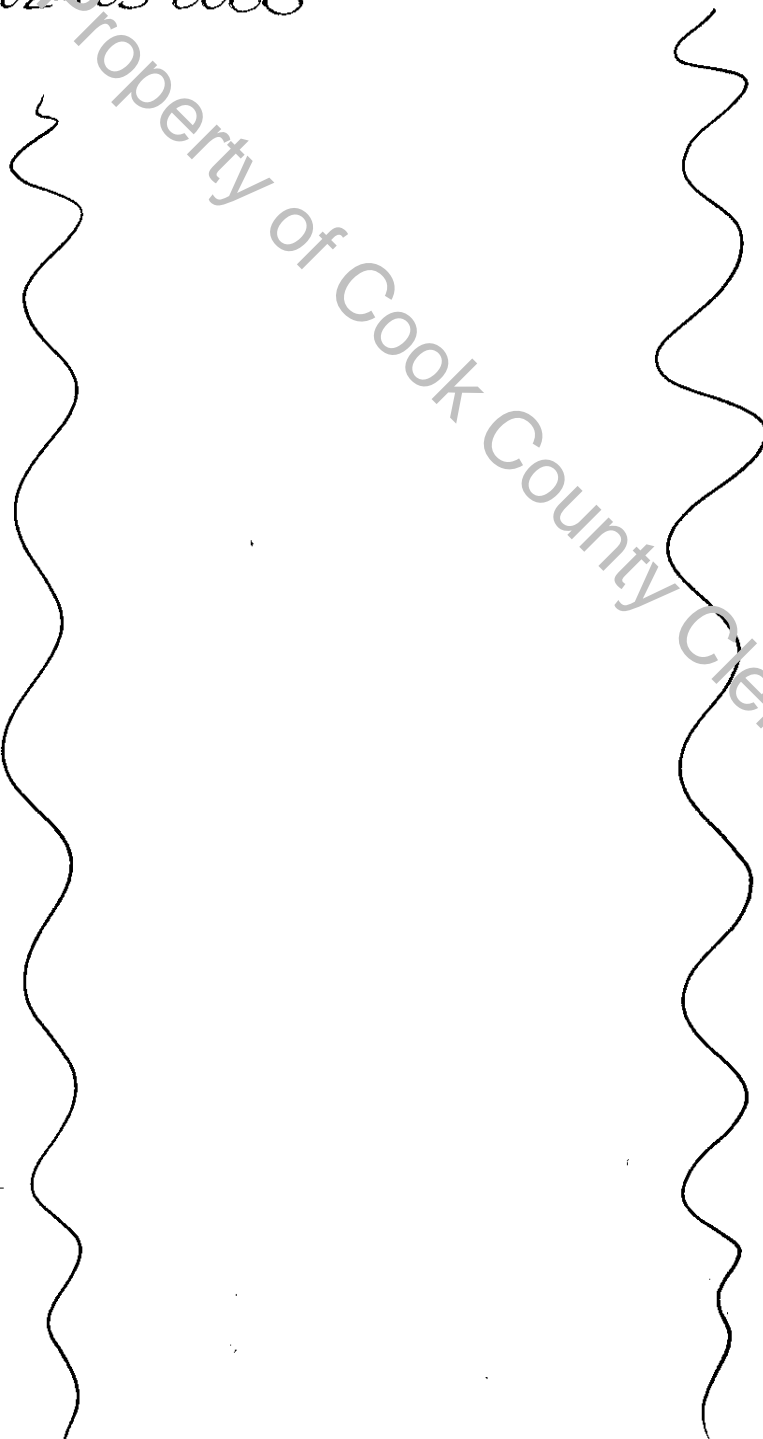
## LEGAL DESCRIPTION RIDER
