That on July 30, 2004 the owner owned the following described land in the County of Cook, State of Illinois, to wit:





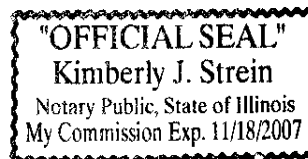
